

### The Case Against Condoms

### **INTRODUCTION**

In the worldwide battle over abortion and population control, there are certain dogmas that the International Planned Parenthood Federation (IPPF) and other "family planners" adhere to under threat of a type of "excommunication" if they do not toe the line.

The most important of these dogmas involves condoms.

The "family planners" believe, in spite of all the scientific evidence, that condoms not only prevent pregnancy, but effectively block the transmission of the HIV virus as well. For example, the Caribbean Family Planning Association, an affiliate of IPPF, distributes a pamphlet entitled "The Condom: 100% Protection Against Pregnancy and AIDS." Alberto Stella, UNAIDS coordinator for Honduras, Nicaragua and Costa Rica, echoed this theme when he claimed that the Catholic Church's opposition to condoms has worsened the AIDS epidemic in Latin America; "In Latin America the use of the condom has been demonized, but if it was used during relations I guarantee the epidemic would be eliminated in the region." <sup>1</sup>

Because they have such blind faith in the condom, such people condemn those who oppose their use in the most vicious possible terms. For example, many journalists have claimed that Pope John Paul II and Pope Benedict XVI are consciously committing "genocide" and are directly causing the deaths of millions of people because they will not allow Catholics the use of condoms. When Pope John Paul II died, The Guardian's Polly Toynbee seized the occasion to attack him and the Church, calling the Vatican "a modern, potent force for cruelty and hypocrisy. ... [The] ban on condoms by the church has caused the death of millions of Catholics and others in areas dominated by Catholic missionaries, in Africa and right across the world. In countries where 50% are infected, millions of very young AIDS orphans are today's immediate victims of the Curia." Comparing Pope John Paul II to Vladimir Lenin, Toynbee went on to say that "they both put extreme ideology before human life and happiness, at unimaginable human cost."2

As the next page of this brochure demonstrates, this is simply the hateful babbling of ignorant bigots in total cognitive surrender. To allege that consistent use of condoms will "eliminate" the HIV/AIDS epidemic is the attitude that is condemning millions to death -- not the advocacy of abstinence before marriage and fidelity after, which is

the only practical way to stop the scourge of AIDS in its tracks.

The primary problem with condoms is their propensity to break, tear or slip off. *Contraceptive Technology* is known worldwide as "the family planner's bible," and is the most authoritative source of information on all aspects of contraception. It tallied the results of fifteen studies of more than 25,000 condoms during actual use, and found that 8.04 percent, or about one in twelve, of the condoms failed. This means that the average person who uses condoms will have more than a 99 percent chance of experiencing at least two failures in a year and a 91 percent chance of having at least five failures in a year. As family planning expert Dr. Helen Singer-Kaplan has said, "Counting on condoms is flirting with death."<sup>3</sup>


The greatest tragedy of all is the immeasurable toll of human suffering inflicted upon trusting people by "family planners" who know that condoms don't work. In Africa, tens of millions have died and millions more are orphans. AIDS wards are overflowing with dying patients who thought that a paper-thin sheath of latex guaranteed their safety -- when the actual path to safety was open to them all the time. They just didn't hear it from the "family planners."

Africa proves that abstinence and fidelity work. As page 7 shows, the twelve African countries that have populations that are ninety percent or more Catholic and Muslim have an average adult HIV infection rate of less than one percent. By contrast, the nations that have populations that are less than one-fourth Catholic and Muslim have an average HIV infection rate of more than eighteen percent -- twenty times higher!

It is time that the "family planners" caught up with the Church and began to teach abstinence and fidelity. This pamphlet provides the scientific proof needed to convince them.

### **CONDOM STUDIES: USES VS. FAILURES**



#### Note on Calculations for This Graph

The probability of X condoms failing over Y uses is a problem involving a simple binomial distribution.

For example, let us examine the probability of condoms failing two times in ten uses given the probability of any one condom failure being 8.08 percent.

If we assume that each condom use is independent of all other uses, the probability of exactly two condoms failing in exactly ten uses is shown below.

$$\frac{10!}{2! \times (10-2)!} \times (0.0808)^2 \times (1-0.808)^{10-2} =$$

$$\frac{10 \times 9 \times 8 \times 7 \times 6 \times 5 \times 4 \times 3 \times 2 \times 1}{(2 \times 1) \times (8 \times 7 \times 6 \times 5 \times 4 \times 3 \times 2 \times 1)} \times (0.0808)^{2} \times (0.9192)^{8} =$$

 $45 \times 0.0065 \times 0.5097 = 0.1491$ , or 14.91 percent

This formula is applied to the set of all numbers where the number of condom uses ranges from one to 100 and where the number of failures equals one to 20. All the curves are then cumulated to

determine the probabilities of one, two, three, four, five, or ten or more condom failures for one to 100 uses.

# THE INEFFECTIVENESS OF CONDOMS AT PREVENTING STDS AND PREGNANCY

"The possible consequences of condom failure when one partner is HIV infected are serious enough and the likelihood of failure sufficiently high that **condom use by risk groups should not be described as 'safe sex'... One test showed that 14.6 percent of condoms used in a clinical trial either broke or slipped off the penis during intercourse or withdrawal.

A survey at a Manchester, England, family planning clinic revealed that 52% of the respondents had experienced condom breakage or slippage during the past three months alone.






